- Assistant General Manager (SLBC) welcomed all the participants of various Banks and requested them to advise Road Map of respective Banks in respect of villages allotted to them under Atal Adarsh Gram Yojna & Villages having population of more than 2000. (A fresh list Bank Wise in respect of AAGY & 2000+ population was provided)
- Shri Vikram S. Bajwa, General Manager explained the importance of providing Banking Services in Atal Adarsh villages and having population of 2000+, in view of priority of State Govt. & Central Govt. respectively and

requested all Banks to expedite the process of providing Banking services at these identified villages.

- Sh. D.K.Talwar, Asstt. General Manager, State Bank of India from LHO New Delhi advised Road Map of State Bank of India in respect of villages allotted uder AAGY & Villages having population of 2000+. He advised that survey work is under process and shall be completed by 31.05.2010 and 50% of villages undr AAGY shall have BC facility by Sept. 2010 and remaining 50% by March 2011. In respect of villages having population of 2000+, the banking facility shall be provided in 50% villages by March 2011 and remaining 50% by March 2012, as per RBI Guidelines.
- Shri V.K. Shrivastava, Deputy General Manager, Punjab National Bank advised Road Map of PNB in respect of villages allotted under AAGY & Villages having population of 2000+. He advised that 10 villages of Dehradun district will have Kiosks by 30.06.2010. Each Kiosk will cover 4 additional villages located within 5 km of Atal Adarsh Gram by appointment of business facilitator.
- Similarly Bank of Baroda, Union Bank of India, Uttaranchal Gramin Bank, Oriental Bank of Commerce and other Banks advised Road Map to provide Banking facilities at these identified villages.
- Shri Vikram S. Bajwa, General Manager, Reserve Bank of India said that the Road Map being advised is not as desired. <u>All Banks must make a</u> <u>concrete Road Map containing inter-alia the following information &</u> <u>submit it to AGM (SLBC) latest by 19.05.2010.</u>
 - 1. Date of completion of Survey
 - 2. Date of appointment of BC and finalization of Technology.
 - 3. Road Map for providing Banking services quarter wise,
- All Banks were advised to discuss dispute if any in respect of name of village allotted with SLBC immediately.
- All the Bank were also advised that if any bank is willing to take villages allotted to other Banks, they my approach SLBC immediately in this regard.

✤ Banks were advised to ensure submission of Road Map as per above latest by 19.05.2010, so that progress is put in next SLBC meeting.
